AFFIDAVIT OF
JENNIFER WINDSOR BALL

Jennifer Windsor Ball, being duly sworn, deposes and says:

1. I am over eighteen years of age and competent to testify to the matters set forth in this Affidavit.

2. I was Brad Cooper's fiancé, and I believe that I am the "Jennifer Wilson" that he referred to in his video deposition taken on October 2, 2008. I learned of the deposition video from a friend in Calgary and telephoned Alice Stubbs on Saturday, October 11, 2008 to inform her that I believe that Brad Cooper intentionally gave her an incorrect last name for me.

3. Brad Cooper and I were romantically involved from September of 1997 through December of 1998. We lived together in an apartment on 8th Avenue in Calgary from June of 1998 through December of 1998. This is the same apartment building that he and Nancy Cooper lived in after we broke up.

4. Brad Cooper and I were in a long term relationship, became formally engaged, and I am certain that he remembers my real name.

5. Throughout our relationship, Brad Cooper was emotionally abusive towards me.

6. He constantly belittled me to other people. He frequently berated me about my weight and my physical appearance. He would make derogatory comments about me to others, even telling people I looked pregnant when I wasn't. I had never before, and have never again, been in a relationship with someone who treated me so poorly.

7. He was emotionally detached and mentally cruel. He would go on business trips, request that I pick him up at the airport, and fail to appear at the airport, never telephoning to let me know that he would not be there.

8. When my grandfather, whom I was very close with, passed away, I called Brad Cooper at work to tell him. He told me he would come home at lunch to check on

me, and never returned home for lunch, that evening, or for the following three days. He never called and would not answer any pages I left for him during this period. It was when he finally returned home I told him, the relationship was over.

9. At the end of our relationship, I became fearful for my physical safety.

10. When we broke up, we agreed that I would take over our apartment and remove his name from the lease. He subsequently cleaned out the apartment without my knowledge and removed all the personal property that belonged to both of us.

11. I was surprised to learn that he had moved into another apartment in the same building on a different floor.

12. I was even more surprised when a neighbor told me that he began secretly accessing my apartment even after his name had been removed from the lease and he had moved out.

13. Brad's behavior was creepy, and I was so disturbed by it that I broke my lease agreement, and moved away so that I would not have to remain in the same building with him.

Further the affiant sayeth naught.

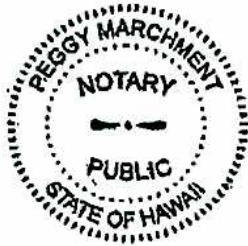


